Welcome to the 65th Annual Spring Meeting of the ABA Section of Antitrust Law, the world's largest meeting of competition and consumer protection professionals. In addition, Antitrust Subcommittee Chairman Mike Lee (United States Senate) (invited) will share his thoughts on what to look for in the year ahead. Wednesday, 12:00pm.
- Chair's Showcase. The Chair's Showcase is entitled "Promoting Competition/ Protecting Consumers: In Sync or At Odds?" and will explore whether consumer protection policy and competition policy are complements or substitutes, how each should account for the other, which authorities should reconcile them, and what arguments will influence the decisions. Thursday, 10:15am.
- Enforcers Roundtable. This gathering of leading competition authorities will include the distinguished heads of both U.S. enforcement agencies, the European Commission, NAAG's Multistate Antitrust Task Force, and Mexico's Competition Bureau. Friday, 10:00am.
- Section Dinner. Enjoy dinner with General David PETRAEUS. The retired four-star Army General, Commander of U.S. Central Command, and Director of Central Intelligence answers our questions about commercial and political relations around the world in a conversation led by Deborah P. Majoras. Thursday, 7:15pm.

**Informal Sessions with Networking Opportunities**. The new Marriot Marquis venue promises ample public spaces to connect, interact, and build new friendships at the world's largest gathering of antitrust and consumer protection professionals. I encourage you to take advantage of this limited opportunity to develop your professional network.

# FIRESIDE CHATS WITH FOREIGN ENFORCERS

During selected times on Wednesday & Thursday, our Former Section Chairs will be conducting individual 30-minute interviews with selected enforcement officials from competition agencies around the globe. These informal interviews will be open on a drop-in basis for all Spring Meeting attendees. The final schedule will be posted prior to the Spring Meeting.





### CLE

The ABA directly applies for and ordinarily receives CLE credit for ABA programs in AK, AL, AR, AZ, CA, CO, DE, GA, GU, HI, IA, IL, IN, KS, KY, LA, MN, MS, MO, MT, NH, NM, NV, NY, NC, ND, OH, OK, OR, PA, PR, SC, TN, TX, UT, VT, VA, VI, WA, WI, and WV. These states sometimes do not approve a program for credit before the program occurs. This transitional program is approved for both newly admitted and experienced attorneys in NY. Attorneys may be eligible to receive CLE credit through reciprocity or attorney self-submission in other states. For more information about CLE accreditation in your state, visit www.ambar.org/ATSpring. States typically decide whether a program qualifies for CLE credit in their jurisdiction 4 to 8 weeks after the program application is submitted. For many live events, credit approval is not received prior to the program.

- DE, IL, NY attendees are required by their state(s) to sign in (and NY also out) of each session.
- DE, IL and NY forms will be located in the back of each session room.

- Over 50 CLE events are scheduled for the Spring Meeting. The sessions are an educational presentation, usually in panel format, presented by one or more of the Section's committees. Sessions where skills training, trial skills, and/or ethics credit has been applied are indicated in the brochure.
- Required sponsor documentation has been forwarded to and credit requested from MCLE states with general requirements for all lawyers. Lawyers seeking credit in PA must pay a fee of \$1.50 per credit hour directly to the PA CLE Board. The ABA pays applicable fees in other states where the sponsor is required to do so. In states where a late fee may become applicable, the ABA pays this fee as well.
- Please be aware that each state has its own rules and regulations, including its definition of "CLE" as well as "Ethics." Therefore, certain sessions may not receive CLE credit in some states. Please check with your state provider for confirmation of general, as well as ethics, approval for any conference.
- The Uniform Certificate of Attendance will be available with your course materials.
- Please check back for the total number of credit hours approved.




